Textual Information()

This with reference to the shareholding pattern under Regulation 31 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 filed for the quarter ended 31.03.2018. In that regard, we would like to inform you that our Company has received a query letter from NSE and BSE regarding the transmission of shares executed from Late Shri. Vijay Kumar Lunawath to Mr. Mangi Lal Lunawath, legal heir of the shareholder. It was explained to the stock exchanges through our letters dated 25.04.2018 to BSE and NSE that Mr. Mangi Lal Lunawath does not belong to the promoter category. It was also reported that the legal heir does not belong to the relatives under sub section (76) of Section 2 of the Companies Act, 2013. We have also made Compliance filing with the BSE portal listing bseindia.com on 13.01.2018 vide transaction no. 13012018537626 under Reg. 7 (2) - Prohibition of Insider Trading Regulations, 2015 and the NEAPS portal www.connect2nse.com/LISTING/ on 13.01.2018 vide transaction no. 27346 under Reg. 7 (2) - Prohibition of Insider Trading Regulations, 2015 intimating the same. Therefore, the shares were categorized under PUBLIC Category. However, NSE vide their letter dated May 29, 2018 has stated that as per the Regulation 31(A)(4) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, in case of transmission/succession/inheritance, the inheritor shall be classified as Promoter. Accordingly, we have requested our RTA revised the shareholding pattern for the quarter ended 31.03.2018 by categorizing the shares held by Mr. Mangi Lal Lunawath to promoter category. Further, we would like to intimate to the stock exchanges that the shares has been categorized under Promoter category only on 12.06.2018 based on the recommendations of the stock exchange. The promoter Mr. Mangi Lal Lunawath as per SEBI Circular Dated November 30, 2015 ref. no. CIR/CFD/CMD/13/2015 has submitted to his DP the share certificates for creation of "Promoter Demat Account" and dematerializing the said shares. The request for demat will be approved in this quarter and updated to the stock exchanges shortly.
